

TERMS AND CONDITIONS OF ENTRY

***CONDITIONS OF ENTRY – Women in Science, Technology, Engineering and Mathematics (“STEM”) Competition**

1. The organiser of this ‘Women in STEM’ competition (“the Competition”) is the Royal Melbourne Institute of Technology ABN 49 781 030 034 (“RMIT”).
2. Entry is open to all students who were enrolled by RMIT as a student in Semester 2 2017, Summer Semester 2017/2018, or Semester 1 2018 and based in RMIT’s Melbourne, Australia campuses (“Eligible Participant(s)”). All staff (excluding enrolled RMIT students engaged as sessional/casual staff) and those on the judging panel and their immediate families are ineligible to enter.
3. A team of Eligible Participant(s) may work together on an entry.
4. To enter, Eligible Participant(s) must submit an eligible entry: (i) created by an Eligible Participant(s); (ii) celebrating a woman in STEM; (iii) include a brief report citing the sources of historical information and any images used; (iv) be factually accurate; (v) use only publically available sources of information, and intellectual property owned by the Eligible Participant(s); and (vi) include the RMIT Student Initiative logo available at <http://titan.csit.rmit.edu.au/~e06876/ada/logos.zip> (an “Eligible Entry”).
5. The Eligible Entry must include a completed entry form. Entry forms are available here: <http://titan.csit.rmit.edu.au/~e06876/ada/> . You must complete all fields on the form.
6. **The Competition commences at 9.00am AEDT on Monday 15th January 2018 and closes at 11:59pm AEDT on Sunday 18th March 2018 (“the Competition Period”).** Any entries received by RMIT before or after the Competition Period are ineligible for entry and no responsibility will be accepted for lost, late or misdirected entries.
7. RMIT reserves the right to exclude entries from consideration on the basis that, in the opinion of RMIT, such entries do not conform to the entry requirements.
8. This is a competition of skill. Chance plays no part in the competition.
9. The winning entrants will receive voucher prizes as follows: 1st prize AU\$1000, 2nd prize AU\$500, 3rd to 13th prize AU\$150 (together the “Prizes”). Where a team entry is selected as the winner of any of the Prizes, each team member must equally share in the Prize. Where no Prizes are awarded, RMIT will manage the prize monies as it sees fit.
10. The winning entries will be chosen by a panel of representatives from RMIT (“the Panel”). The Prizes will be awarded for (a) eligibility of entry, (b) the degree to which the information in the entry is interesting and inspirational in presenting the chosen woman in STEM and her contribution, and (c) the aesthetics of poster design, as judged by the Panel. The Panel’s decision will be final and no correspondence will be entered into.
11. Winners will be notified by telephone and email on Thursday 5th April 2018.
12. RMIT may publish the name of the winners on its websites and official social media channels. Awards will be made at a poster launch to be held in April 2018. Attendance at the poster launch is at the cost of each winner.
13. All entries will remain anonymous until the winners are announced.
14. The winners agree to be profiled by RMIT for promotional, marketing and publicity purposes. This may be through print or online channels.

15. All Prizes are inclusive of any costs which the entrants may incur in entering this Competition.
16. The Prizes will be paid in the form of vouchers. Where the Prize is awarded to a team entry, it is the team's responsibility to equally share the Prize amongst each Eligible Participant within the team.
17. RMIT collects entrants' personal information in order to conduct the Competition. If the information requested is not provided, the entrant may not participate in the Competition. By entering, each entrant agrees that RMIT may use their personal information for marketing and promotional purposes, including sending the entrant electronic messages, using the entrants details in publication of their entry and including further use as set out in these Terms and Conditions of Entry.
18. RMIT is not liable for loss/damage suffered (included but not limited to indirect/consequential loss), or for personal injury suffered/sustained, as a result of entering the Competition or accepting any of the Prizes, except for any liability which cannot be excluded by law.
19. RMIT's decisions in respect of all matters to do with the Competition will be final, and no further correspondence will be entered into.
20. By entering this Competition, an Eligible Participant is indicating their agreement to be bound by these Terms and Conditions of Entry.
21. The Competition and its terms and conditions will be governed by Australian law and any disputes will be subject to the exclusive jurisdiction of the courts of Australia.
22. Each Eligible Participant assigns all intellectual property rights in their entry to RMIT for RMIT to use at RMIT's discretion including, without limitation, to (i) use, reproduce, publish and display their entry in any of RMIT's media or distribution methods and to authorise any third party to do so; (ii) amend as needed, and (iii) to use with or without attribution of authorship. RMIT will use reasonable endeavours to attribute authorship where possible. Each Eligible Participant warrants that its entry does not breach copyright or other intellectual property rights of any person.
23. RMIT reserves the right to cancel or amend the competition and these Terms and Conditions of Entry without notice. RMIT will notify any changes to the competition to entrants as soon as possible.
